

Doctoral Studies - Applicants with Foreign Qualification

Fact Sheet: Documents to Submit, Faculty of Medicine

When filling out the online application form, under the section "documents to submit" you will be asked to upload the following documents:

- Signed declaration of consent
- Current photo, in color, aspect ratio 3:4, image size at least 400x533 pixel
 For the <u>UZH Card</u>. Please make sure that the aspect ratio is correct, and edit the photo if necessary. Your head should be photographed in a frontal pose against a neutral background providing good contrast, and it should take up about 80% of the photo.
- Copy of official identification (passport or ID, no residence permit)
 Please scan the front and back of your ID.
- CV

Please list all matriculations at a higher education institution, including matriculations in a discontinued or ongoing program.

- Upper secondary school-leaving certificate
 Please scan all pages of the document. If you have studied at a Swiss university before, also scan the sticker with the Student ID Number.
- Bachelor's diploma, including diploma supplement and transcript of records as well as Master's diploma or equivalent university diploma, including diploma supplement and transcript of records¹

If you have not yet completed your studies you will need to provide an official interim transcript of records and precise information on the status of your studies (requirements still to be met and your probable date of completion).

- → Please upload these documents only unchanged (i.e. in the original downloaded form) to the Application Portal. Any modifications (e.g. by using «Print as PDF», saving under a different name, printing and scanning, merging files, etc.) will result in the loss of any existing electronic signature, which makes digital verification of such documents impossible.
- <u>Confirmation of supervision from the authorized examiner</u> (form: Betreuungsbestätigung für Doktorierende)

For applications for an individual doctorate:

Decision on recognition by MEBEKO (The Federal Office of Public Health)

If applying with a German qualification:

Only the document ,Zeugnis über die Ärztliche Prüfung' is required, the ,Approbation' does
not have to be submitted. Please upload in the list of documents under 'Transcript of records.'

For applications for a doctoral program:

Notification of acceptance to a doctoral program
 This document will either be sent to you by the institute or graduate school once you are accepted for the program, or has already been sent to you.

Applicants for Doctoral Studies at the Faculty of Medicine do <u>not</u> have to submit **Course contents**: **Brief overview of content of attended modules/courses**.

Please provide us with all documents (except your passport photo) in PDF format.

Only one file can be uploaded for each point. This means you should please create a single file for multiple-page documents or multiple documents that are thematically linked.

All documents that are not in German, English, French or Italian must be uploaded along with a **copy of an officially certified translation**. In this connection please be sure to take note of the <u>guidance</u> on certified translations.

A translation of the **upper secondary school-leaving certificate/university entrance qualification** is only necessary for documents not issued in the Roman, Greek or Cyrillic alphabet.
